

# Independent Advocacy

- ★ Independent from the Local Authority
- **★** Child-led they often self refer
- ★ Represent the wishes and feelings of children and young people – 'advocates do not have a professional opinion'
- **X** Can help make complaints
- **X** Project workers
- ★ Mostly issue based
- ★ Non-instructed advocacy





# Ways children communicate

- \* Facial expressions
- ✗ Body language, gestures, pointing, eye movements
- ★ Sign language and Makaton
- **X** Symbols
- X Art, play, drama, writing
- \* Assisted devices
- X Speaking and verbalisation























# Non-Instructed Advocacy

"Non-instructed advocacy is taking affirmative action with or on behalf of a person who is unable to give clear direction of their views or wishes in a specific situation. The non-instructed advocate seeks to uphold the person's rights; ensure fair and equal treatment and access to services; and make certain that decisions are taken with due consideration for their unique preferences and perspectives".

# Family Justice Young People's Board

40 Children and young people from a range of backgrounds









#### **Positive Initiatives**

- Crèche facility.
- Toy box loan scheme.
- Court public open days and tours.
- Café.
- Well resourced family rooms.

#### **Key Learning**

- No family rooms.
- Lack of toys and resources.
- Little or no information for children and young people is found in court buildings.
- Expensive or no refreshments available.
- No opportunity for feedback.







#### **Children's Feedback:**

- All felt that the Judge listened to them and valued what they had to say.
- All felt that they had enough time to talk to the Judge, this varied between 30 – 60 minutes.
- Waiting areas were though to be welcoming, tidy and dull.
- Court staff were considered to be kind, welcoming and friendly.
- Judges were said to be welcoming, understanding, nice, kind and happy.





### **Final Thoughts**

Children with disabilities have the same right to be included in decisions that affect their life. As professionals it is our responsibility to do everything we can to promote and facilitate that right. To do this effectively takes time, creativity, flexibility and a positive attitude.
